## Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

(a) the details of National institutes functioning under the Ministry for the welfare of differently abled persons, State-wise;

(b) whether it is true that a large number of persons employed in these institutes are still working on casual/contract basis despite many vacant posts available in these institute, particularly in the National Institute of Mentally Handicapped.

(c) If so, the details thereof and the reasons therefor; and

(d) the steps taken by the Government to accommodate these casual/contractual employees against permanent posts?

## Answer

## MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI KRISHANPAL GURJAR)

(a) There are seven National Institutes under this Department working in the field of disability. These institutes are engaged in Human Resources Development in the field of disability, providing rehabilitation services to the persons with disabilities and Research and Development efforts. The seven National Institutes are as follows:-

(i) National Institute for the Visually Handicapped (NIVH), Dehradun.

(ii) National Institute for Empowerment of Persons with Multiple Disabilities (NIEPMD), Chennai.

(iii) Swami Vivekanand National Institute for the Rehabilitation, Training and Research (SVNIRTAR), Cuttack.

(iv) Ali Yavar Jung National Institute for the Hearing Handicapped (AYJNIHH), Mumbai.

(v) National Institute for the Mentally Handicapped (NIMH), Secunderabad.

(vi) National Institute for the Orthopaedically Handicapped (NIOH), Kolkata.

(vii) Pt. Deendayal Upadhyaya Institute for the Physically Handicapped, IPH, New Delhi.

(b) & (c) Persons have been engaged by the National Institutes against the regular vacant posts on contract basis for short period. This is temporary arrangement so that the work is not adversely affected. Besides that National Institute have also outsourced persons through agencies/firms for carrying out works at these National Institutes. However, necessary action has been initiated fill up these vacancies. Details of the vacancies as well as contract/ outsourced employees working in the National Institutes are given below:-
