- (a) Whether completion of metro rail work on various stretches, including Bangalore metro projects is being delayed;
- (b) If so, the details thereof and the reasons therefor, stretch and city-wise along with the loss suffered by the Government as a result thereof:
- (c) The steps taken/being taken by the Government to expedite the work;
- (d) Whether the Government has signed agreements with foreign countries for metro rail services and if so, the details thereof, country-wise:
- (e) The details of accidents reported during the metro construction work, city and State-wise;
- (f) Whether the compensation has been paid to the next kin of deceased in each case and if so, the details thereof and if not the reasons therefore along with the action taken/being taken by the Government in this regard; and
- (g) Whether the Government propose to operate light rail system such as an elevated tramway for smaller cities and towns and if so, the details thereof?

## Answer

- (a) Yes, Madam. Some of the ongoing Metro Projects including Bangalore Metro Rail Project being implemented on 50:50 equity sharing joint venture between Government of India (GoI) and the concerned State Governments are delayed.
- (b) The details of delay, reasons thereof alongwith loss suffered by Government stretch/ city-wise are given in Annexure-I.
- (c): The progress of Metro Rail projects is reviewed periodically by Gol, State Governments and the concerned Metro Railway Board of Directors (BoDs) from time to time. Appropriate action such as holding of meetings, resolving the issues causing delay in the project etc. with the concerned Ministries/Departments/Agencies is being taken up by Gol.
- (d) No Madam.
- (e&f): The details of accidents reported, compensation paid/not paid to the next kin of deceased in accident during construction of Metro Rail projects implemented/being implemented on 50:50 Joint Venture of Gol and the respective State Government, State/city-wise is given in the Annexure-II.
- (g): As per National Urban Transport Policy, 2006, Gol supports all modes of public transport systems proposed by State Governments. No proposal of light rail system such as elevated tramway has been received in this Ministry for consideration/sanction.
