- (a) & (b) Yes Madam, The Government of Assam has been requested to engage a consultant for the revision of the nomination dossier on Majuli Island as per the latest Operational Guidelines of UNESCO. Archaeological Survey of India is ready to extend technical support in this regard.
- (b) & (d) Development and promotion of tourism is primarily the responsibility of the respective State Governments. However, the Ministry of Tourism provides Central Financial Assistance (CFA) to various State Governments for various tourism projects consultation with them subject to availability of funds, inter-se priority and adherence to the scheme guidelines.
