- (d): The Government has in the last one year embarked upon a number of initiatives that address the multiple concerns affecting farming as an enterprise. The emphasis of the Government is on (i) production front with a view to enhancing productivity and on a sustainable basis; (ii) on post- production front, that takes care of marketing concerns; ((iii) credit facilitation. Each of these intervention is being made across the country including Gujarat, through following new schemes as follows:-
- (i) Soil Health Card (SHC)
- (ii) Paramparagat Krishi Vikas Yojana (PKVY)
- (iii) Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)
- (iv) Agri-tech Infrastructure fund
- (v) Price-stabilization fund

Credit Facilitation:-

Enhanced credit target to the farm sector.

Further, the Department of Agriculture & Cooperation has launched a new scheme called "Krishonnati Yojana" as shown below:-

- 1. Krishonnati Yojana
- (a) National Food Security Mission (NFSM)
- (b) Mission for Integrated Development of Horticulture (MIDH)
- (c) National Mission on Oilseeds & Oil Palm (NMOOP)
- (d) National Mission for Sustainable Agriculture (NMSA)
- (e) National Mission on Agricultural Extension & Technology
- (f) Integrated Scheme on Agriculture Marketing

All the above schemes alongwith the following schemes help in enhancing production and productivity, risk mitigation, price support etc. Simultaneously, focus is on reducing cost of cultivation. Schemes like PKVY, SHC and promotion of neem coated urea will bring about reduction of cost of cultivation, while simultaneously achieving higher yield levels.
