Will the Minister of MINES be pleased to state:

- (a) whether any payment has been made by the Union Government to the Indian Space Research Organisation (ISRO) and other telecommunication organisations for tracing out illegal mining in the country; if so, the details thereof;
- (b) whether fresh recommendations have been made by some State Governments and sanction has been granted by the Union Government to certain companies found involved in illegal mining in different parts of the country and also violating the orders of the Supreme Court;
- (c) if so, the details thereof and the reasons therefor, company-wise and State/ UT-wise;
- (d) whether reports regarding the status of illegal mining have been sought by the Union Government from some of the State Governments; and
- (e) if so, the details thereof along with the action taken by the Government in this regard?

Answer

- (a): No Madam. However, the Indian Bureau of Mines (a subordinate office of the Ministry of Mines) has procured 13 satellite imageries from National Remote Sensing Centre (NRSC), Indian Space Research Organisation at a cost of Rs.1,08,000/- for identification of mining excavations towards formulation of mineral development plan in Adityana & Bhakharala villages in Porbandar district of Gujarat.

- (c): Does not arise in view of reply given to (b) above.
- (d) & (e): Based on the quarterly returns on illegal mining submitted by various State Governments to Indian Bureau of Mines (a subordinate office under the Ministry of Mines), state-wise details of instances of illegal mining reported in various parts of the country for last three years details along with the action taken by the Government in this regard is given in ANNEXURE.
