- (a) Yes, Madam. A committee of Ministry of Culture has recommended a Special Force for protection of Museums objects and protected monuments as part of a comprehensive security policy.
- (b) The Committee so constituted has recommended measures to be taken towards securing cultural assets by physical deployment and with the help of tools and electronic gadgets, etc. including a force.
- (c)to(f) At present the cultural assets are provided with security by regular watch and ward staff, Home Guards, CISF and private security guards.
