Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether India has entered into cooperation on health with a number of countries in the recent past and if so, the details thereof;

(b) whether a high level delegation has recently visited the United States of America for cooperation in health sector;

(c) if so, the details thereof along with the issues discussed and agreed upon by the two countries; and

(d) the manner and extent to which Indian health sector is likely to be benefited from such international cooperation on health?

Answer

THE MINISTER OF HEALTH AND FAMILY WELFARE (DR. HARSH VARDHAN)

(a): The Ministry of Health & Family Welfare has signed the following Memoranda of Understanding (MoUs) / Agreements / Statement of Intents (Sols) for cooperation in Health sector, during the period from 01.04.2013 till date:-

(b) & (c): Minister of Health & Family Welfare (HFM) visited the United States of America from 24th June to 28th June, 2014. The visit was undertaken primarily to participate in the 'Acting on the Call' conference organised to deliberate on ending the preventable child and maternal deaths, which was co-hosted by India, Ethiopia, USA and UNICEF at Washington DC. During the course of the visit, HFM had meetings with the senior functionaries and technical experts in the US Government and the representatives of UN Agencies and other international organisations engaged in health sector, including a bilateral meeting with Ms. Sylvia Mathews Burwell, US Secretary of Health & Human Services and Dr. Rajiv Shah, USAID Administrator on 24th June, 2014 and Dr. Tom Frieden, Director, CDC Atlanta on 27th June, 2014. In addition to the above, the Minister was invited as Chief Guest in the American Association of Physicians of Indian Origin (AAPI) Conference on 28th June, 2014 at San Antonio. During the meetings, discussions were held on various important health related issues such as Global Health Security, Acute Encephalitis Syndrome / Japanese Encephalitis, (Tuberculosis) Non communicable Diseases & Tobacco Control, Maternal & Child Health issues, Injuries & Trauma, Occupational & Environmental Health etc. .
