(a) whether the Government proposes to take steps for inclusion of various Indian cities/heritage sites in the UNESCO's World Heritage list;

(b) if so, the details thereof and the present status of the cities/heritage sites along with the policy/criteria adopted by the UNESCO to include ancient sites/tourist places in World Heritage List, State-wise;

(c) whether the Government has submitted proposals of various Cities in the country to UNESCO for bestowing them the World Heritage status; and

(d) if so, the details thereof along with the status of the proposal?

(a) & (b): Yes. Madam, the Government has taken steps for inclusion of various Indian cities/heritage sites in UNESCO's World Heritage list. At present India has 32 cultural and natural sites on the World Heritage List (Annexure-I). Moreover, there are 46 sites including Indian Cities, monuments, archaeological sites, etc. on UNESCO's tentative list, which is a mandatory requirement before a site is finally considered for the nomination. The list is given at (Annexure-II). As per the Operational Guidelines the criteria adopted by UNESCO to include ancient sites/tourist places in World Heritage List, are given at (Annexure-III).

(c) & (d): Yes. Madam, the two nomination proposals on cities i.e 'Delhi's Imperial Capital Cities' and 'the Victorian and Art Deco Ensemble of Mumbai' were submitted to World Heritage Centre in January, 2014 in which Delhi was prioritized. Before the 39th Session of World Heritage Committee in July 2015 the proposing State Party had requested UNESCO Secretariat for postponement of the consideration of the nomination of 'Delhi's Imperial Capital Cities'.

ANNEXURE REFERRED TO IN REPLY TO PART (b) OF LOK SABHA UNSTARRED QUESTION NO. 3620 FOR 21.12.2015

As per the Operational Guidelines the criteria adopted by the UNESCO.

- (i) represent a masterpiece of human creative genius;
- (ii) exhibit an important interchange of human values, over a span of time or within a cultural area of the world, on developments in architecture or technology, monumental arts, town-planning or landscape design;
- (iii) bear a unique or at least exceptional testimony to a cultural tradition or to a civilization which is living or which has disappeared;
- (iv) be an outstanding example of a type of building, architectural or technological ensemble or landscape which illustrates (a) significant stage (s) in human history;
- (v) be an outstanding example of a traditional human settlement, land-use, or sea-use which is representative of a culture (or cultures), or human interaction with the environment especially when it has become vulnerable under the impact of irreversible change;
- (vi) be directly or tangibly associated with events or living traditions, with ideas, or with beliefs, with artistic and literary works of outstanding universal significance. (The Committee considers that this criterion should preferably be used in conjunction with other criteria);
- (vii) contain superlative natural phenomena or areas of exceptional natural beauty and aesthetic importance
- (viii) be outstanding examples representing major stages of earth's history. Including the record of life, significant on-going geological processes in the development of landforms, or significant geomorphic or physiographic feature;
- (ix) be outstanding examples representing significant on-going geological and biological processes in the evolution and development of terrestrial, fresh water, coastal and marine ecosystem and communities of plants and animals;
- (x) contain the most important and significant natural habitats for in-situ conservation of biological diversity, including those containing threatened species of outstanding universal value from the point of view of science or conservation.
