- (a) the details of Electronic Manufacturing Clusters approved /sanctioned so far, State-wise;
- (b) the details of proposals pending with the Union Government;
- (c) whether electronics cluster under the Make in India programme have been sanctioned to the various states including Kerala;
- (d) if so, the details thereof along with the funds granted therefor ; and
- (e) whether the formation of Special Purpose Vehicle has been completed and if so, the details thereof?

Answer

(a) to (e): A statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED
Q. NO. *154 FOR 27.07.2016 ON ELECTRONICS MANUFACTURING CLUSTER

(a): Under the Electronics Manufacturing Cluster (EMC) Scheme, Department of Electronics and Information Technology (DeitY), Government of India has approved setting up of nine (9) Greenfield Electronics Manufacturing Clusters and one (1) Common Facility Centre (CFC) in Brownfield Electronics Manufacturing Cluster. The state wise details of the approved Electronics Manufacturing Cluster are annexed at Annexure-I.

(b): Under the EMC scheme, till date, DeitY has received 44 applications from 18 states out of which final approval has been accorded to ten (10) applications and in-principle approval has been accorded to eighteen (18) applications. Of the eighteen (18) applications for which in-principle approval has been accorded, final applications are awaited from seven (7) applicants. In eleven (11) cases, final applications have been received and are under appraisal for final approval. Further, ten (10) applications have been withdrawn /closed and in- principle approval for one (1) application has been cancelled. Five (5) applications are under preliminary appraisal. The details of the applications which are pending (under preliminary and final appraisal process) are attached at Annexure-II (A) & (B).

(c) and (d): In respect of the state of Kerala, an application for setting up of a Greenfield Electronics Manufacturing Cluster at Kakinada Village in Kanayannur Taluk of Ernakulam District has been submitted by M/s. Kerala Industrial Infrastructure Development Corporation (KINFRA). The Steering Committee for Cluster (SCC) headed by Secretary, DeitY in its meeting held on 17th June 2016 has recommended the said application for final approval.

(e): In accordance to the Guidelines for constitution of Special Purpose Vehicle (SPV) each Electronics Manufacturing Cluster (EMC) will have a separate SPV, which will be responsible for implementation and management of the project. Out of the ten (10) finally approved EMCs, SPV has been formed in three (3) projects. Details of the projects wherein SPVs have been formed are attached at Annexure-III.
