Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANAGA REJUVENATION be pleased to state:

(a) the details of ongoing/pending water projects in the country, State/UT-wise, particularly in Madhya Pradesh;

(b) whether the sanctioned/allocated funds have been released to various water projects including Bilaspur and Chambal command area development projects, and if so, the details thereof;

(c) whether the Government has received proposals for various water projects/programmes like Uper Kekato Project, Kachhal Project, Rehate Project, Bargharu and Kushalpura projects from the Government of Madhya Pradesh, and if so, the details thereof along with the decision taken in this regard;

(d) whether the Government of Madhya Pradesh has submitted the proposals of Extension, Renovation and Modernization (ERM) of Rajghat Canal Project and Tawa Projects for augmenting the irrigation capacity of dams, to the Central Water Commission, and if so, the details thereof; and

(e) the follow-up action taken thereon?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF STARRED QUESTION NO. *165. TO BE ANSWERED ON 28.07.2016 IN LOK SABHA REGARDING "WATER PROJECTS" ASKED BY SHRI MANOHAR UTAWAL HON'BLE M.P., LOK SABHA:

(a) & (b) Water Resources Project are planned, funded, executed and maintained by the State Governments themselves as per their own resources and priority. In order to supplement the efforts of the State Governments, Ministry of Water Resources, River Development & Ganga Rejuvenation (MoWR,RD&GR) provides technical and financial assistance to State Governments to encourage sustainable development and efficient management of water resources through Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) under its components PMKSY-Accelerated Irrigation Benefits Programme (AIBP); and PMKSY-Har Khet Ko Pani (HKKP). State wise details of ongoing projects including those in Madhya Pradesh under PMKSY-AIBP and PMKSY-HKKP [Schemes under Command Area Development & Water Management (CADWM), Repair, Renovation and Restoration(RRR) of water bodies and Surface Minor Irrigation (SMI)] are given at Annexure-I.

During 2015-16, central assistance (CA) of Rs. 2327.82 Cr. was released for 36 projects under AIBP, Rs. 1142.71 Cr. for 108 projects under CADWM, Rs. 161.18 Cr. for 1099 water bodies and Rs. 601.92 Cr. for 2374 SMI schemes. State-wise details of CA released is given at Annexure-II.

The CADWM proposal for Bisalpur Project has not been received from the Government of Madhya Pradesh. Further chambel CAD project of Madhya Pradesh has been completed during 2003-04, however, CA of Rs. 7.73 Cr. for Chambal and Rs. 7.90 Cr. for Bisalpur Command Area Projects has been released during 2015-16 under CADWM scheme in the State of Rajasthan.

(c) Kachal, Rehate, Bagharau, Uper Kekato and Kushalpura projects of Madhya Pradesh are not in the list of ongoing AIBP projects. However, Kachal, Rehate and Bagharau projects of Madhya Pradesh are included under CADWM programme. CA of Rs. 1.23 cr. for Bagharau and Rs. 1.25 cr. for Kachal CAD project has been released during 2015-16. Proposal for CA release with respect of Rehate CAD project has not been received during 2015-16.

Further, proposals of Uper Kekato and Kushalpura projects have not been received from the State Government for inclusion under CADWM programme.

(d) & (e) Revised Cost Estimate of Extension, Renovation and Modernisation (ERM) of Rajghat Canal Project has already been accepted by the Advisory Committee of MoWR, RD & GR in its 125th meeting held on 25.05.2015. The proposal of ERM of Tawa Irrigation Project was also considered in 125th meeting of the Advisory Committee of MoWR, RD & GR could not be approved for want of Environmental clearance.
