- (a) the major schemes of the Ministry aimed at addressing ever growing urban poverty in the country;
- (b) the allocations made to address urban poverty across the country and the funds spent/unspent during the last three years;
- (c) the reasons for unspent allocations during the said period; and
- (d) the action initiated against those who failed to spend the allocations during this period?

Answer

THE MINISTER OF STATE IN THE MIINSTRY OF HOUSING & URBAN POVERTY ALLEVIATION (RAO INDERJIT SINGH)

(a): This Ministry is implementing "Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM)" to reduce poverty and vulnerability of the urban poor households by enabling them to access gainful self-employment and skilled wage employment opportunities and by building strong grassroot level institutions of the poor. The Mission also aims at providing shelter equipped with essential services to the urban homeless in a phased manner. In addition, the Mission also addresses livelihood concerns of the urban street vendors by facilitating

access to suitable spaces, institutional credit, social security and skills to the urban street vendors for accessing emerging market opportunities

- (b): Details of funds allocated, released and utilized by States/UTs under DAY-NULM during the last three years under DAY-NULM is at Annexure-I.
- (c) & (d) :Swarna Jayanti Shahri Rojgar Yojana was restructured and replaced by DAY-NULM in September 2013. Under DAY-NULM, the States/UTs had to put in place the institutional mechanism for governance and implementation of the Mission, as mandated by the Mission guidelines. This took time which affected the fund utilization by the States at the beginning of the Mission. As per the instructions of Ministry of Finance, funds are released to the States on the basis of their allocation and utilization. If a State failed to utilize the funds available with it, further release of funds was reduced to the extent of unspent balance available with the State.
