- (a) the details of AYUSH hospitals/ dispensaries including research centres functioning at present in the country, stream-wise and State/UT-wise along with the number of hospitals set up during the last two years;
- (b) whether the Government has received a number of proposals from various States for upgradation/setting up of new AYUSH hospitals/dispensaries and if so, the details thereof, State/UT-wise along with the response of the Government thereon;
- (c) whether the Government proposes to open new hospitals, dispensaries and research centres in various States of the country and if so, the details thereof, State/UT-wise, location-wise and streamwise;
- (d) the funds earmarked for the purpose along with the time by which the said institutions are likely to be started; and
- (e) whether there is any proposal to set up multi-speciality AYUSH hospitals in the country and if so, the details thereof, State/UT-wise including Kerala?

- (a): The details of AYUSH hospitals/ dispensaries including research centres functioning at present in the country, stream-wise and State/UT-wise is enclosed as Annexure −I. Further, setting up of AYUSH hospitals comes under the purview of State /UT government. However, the details of upto 50 bedded integrated AYUSH hospitals approved under Centrally Sponsored Scheme of National AYUSH Mission (NAM) during the last two years State/UT-wise is furnished at Annexure-II. - (b): Yes. The number of proposals received by the Government under Centrally Sponsored Scheme of National AYUSH Mission from various States for upgradation/setting up of new AYUSH hospitals/dispensaries, State/UT-wise during current year is furnished at Annexure-III.
- (c): Health is a State subject. However, under Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is a provision of setting up of upto 50 bedded integrated AYUSH Hospital. The details of upto 50 bedded integrated AYUSH hospitals approved under NAM during the last two years State/UT-wise is furnished at Annexure-II. Further, Government has approved setting up of Post Graduate Institute of Yoga and Naturopathy Education and Research at Nagmangla (Karnataka) and Jhajjar (Haryana).
- (d): Rs. 440.00 Crore has been earmarked under National AYUSH Mission (NAM) for different activities including upgradation/setting up of new AYUSH hospitals/dispensaries during current year. Implementation of approved projects comes under purview of State/UT Governments. Further, the total cost approved for setting up of the institutes at Nagmangla (Karnataka) and Jhajjar (Haryana) are Rs. 59.67 Crores and Rs. 52.04 crores respectively.
- (e): There is no proposal to set up multi-speciality AYUSH hospitals in the States/ UTs including Kerala. …………………
