- (d) whether the Government has set any target to further growth in the said sector; and
- (e) if so, the details along with the steps taken to achieve the set target?

(a) and (b): The requested information is not maintained by Department of Pharmaceuticals. (d) and (e): The Twelfth Plan document had set an objective of achieving a compound annual growth rate (CAGR) of 18 per cent for the sector. To facilitate achieving the growth objective, the Government has approved setting up of dedicated research facility in bulk drug, the Scheme for Cluster Development Programme for Pharma Sector, capacity building of private sector etc. In addition, Government has also set up three Task Forces with representation from Ministries/Departments and Industry Associations to look into the concerns of the Industry and give recommendations for addressing them.
