STATEMENT AS REFERRED TO IN PART (a) TO (c) OF THE REPLY TO LOK SABHA STARRED QUESTION NO. 55 TO BE ANSWERED ON 26.11.2014 ASKED BY SHRI PRATAPRAO JADHAV AND SHRI CHANDRAKANT KHAIRE REGARDING IRREGULARITIES IN ENGINEERING COLLEGES.

(a): The total number of cases reported in connection with cheating, irregularities and other malpractices during the engineering entrance examination conducted by Central Board of Secondary Education (CBSE) in last three years are as below:

There was no complaint regarding leaking of question papers in the engineering entrance examination during last three years.

(b): The result of all these candidates was cancelled. Further, the cases of impersonation are reported by the superintendent of respective examination centre to the local police for taking further necessary action against such candidates. The state-wise and year-wise number of candidates found guilty in the engineering entrance examination during last three years is as below:
