- (a) the criteria laid down for allocation of funds to the States from the Central Road Fund (CRF) along with the funds allocated to the States including revenue generated during each of the last three years;
- (b) whether the proposals received from States/UTs for the construction of roads and bridges from CRF during each of the last three years have been approved;
- (c) if not, the details thereof along with the reasons therefor including the details of the proposals approved and funds disbursed;
- (d) whether any mechanism exists to monitor the utilisation of funds sanctioned from CRF so as to ensure that the funds are not diverted by the States and if so, the details thereof including action taken thereon; and
- (e) whether the Government proposes to construct roads in the rural areas of each Lok Sabha Constituency from CRF on the recommendation of the Member of Parliament and if so, the details thereof?

- (a) The funds for development of State roads under Central Road Fund (CRF) scheme are distributed to the States on the basis of 30% weightage to fuel consumption and 70% weightage to the geographical area of the States. Details of funds allocated to States/UTs under CRF during last three financial years are given below:
