DEVELOPMENT OF MSMEs SECTOR

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of various developmental schemes/ programmes implemented by the Government along with the fund allocated and utilised for development of the Micro, Small and Medium Enterprises (MSMEs) sector in the country during each of the last three years and the current year; State/ UT-wise;
- (b) whether the Government has held discussion with the representatives of Micro, Small and Medium Enterprises (MSMEs) sector recently in this regard;
- (c) if so, the details and the outcome thereof; and
- (d) the steps taken by the Government to promote MSMEs sector in the country?

Answer

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI KALRAJ MISHRA)

(a): The Ministry of Micro, Small and Medium Enterprises (MSME) has been implementing various schemes and programmes for development and promotion of Micro, Small and Medium Enterprise (MSMEs) across the country. The major schemes / programmes include Prime Minister's Employment Generation Programme (PMEGP), Credit Guarantee Scheme, Credit Linked Capital Subsidy Scheme (CLCSS), National Manufacturing Competitiveness Programme, Cluster Development Programme, Marketing Development Assistance, Skill Development Programmes, International Cooperation Scheme etc. All plan schemes implemented by Ministry of MSME are Central Sector Schemes. Therefore, funds are not allocated State-wise, under these schemes. However, the details of fund allocated and utilized under various schemes of the Ministry at all India level during the last three years and the current are, as under:-
