Will the Minister of FINANCE be pleased to state:

(a) the details of pharmaceutical companies listed in Indian Stock Exchanges having foreign equity, company-wise during each of the last three years and the current year;

(b) the details of manufacturing units of pharmaceutical companies having foreign equity have been closed during the same period and the reasons for closure;

(c) the details of such companies delisted and that continuing marketing during the same period; and

(d) the reaction of the Government in the matter?

Answer

MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JAYANT SINHA)

(a): The details of pharmaceutical companies listed with Indian stock exchanges having foreign equity as provided by Securities and Exchange Board of India (SEBI) is at Annexure.

(b): SEBI based on information received from stock exchanges, BSE Ltd. (BSE) and National Stock Exchange of India Ltd. (NSE), has stated that units of two pharmaceutical companies, having foreign equity have been closed. These companies are namely Senbo Industries Ltd. (listed on BSE) and Glaxo Smith Kline Pharmaceuticals Ltd (listed on BSE and NSE). The Board of Directors of the Snebo industries Ltd. have resolved closure of the factory of the Company at Karbala, Sonarpur Station Road, P.O. Narendrapur, Kolkata. Further, the Thane factory of Glaxo Smith Kline Pharmaceuticals Ltd has ceased operations after all workmen at Thane Factory (except, one who has retired on July 31, 2012) of the Company have taken Voluntary Retirement under the Scheme offered by the Company.

(c) & (d): The details of pharmaceutical companies delisted during the period January 1, 2011 till December 15, 2014 are as follows:
