According to old policy, if an industrialist or an owner of an industry, where above 100 labourers were employed, wanted to closed down the unit, it was mandatory for him to take permission from the Government. But, now the Government of Maharashtra have amended said Act and now as per latest provision, if more than 300 labourers are employed in an industry, permission is required before closing down such industry, but if the number of labour employed is below 300, then there is no need to take such permission from the Government. This decision of the Government of Maharashtra has put entire industrial world and the labourer class in crisis. All political parties have declared a state wide bandh in protest of this decision. Today, anti-labour policies are being framed all over the nation, consequently entire labour force has started feeling itself insecure. To protect the interest of labourers there is need for the Union Government to interfere in this regard.

SHRI SUSHIL KUMAR SHINDE: Mr. Deputy Speaker, Sir, I am grateful to you and the hon. Prime Minister. In view of the importance of this matter, hon. Prime Minister in present in the House since this matter relates to promotion and general employment of Scheduled Castes and Scheduled Tribes. Former Prime Minister, Late Shri Rajiv Gandhi once took up this issue and launched a nation wide drive to fill backlog vacancies of SCs/STs. Present Prime Minister had also taken similar decision. An assurance was given in this regard during the conference of National Scheduled Castes and Scheduled Tribes Commission that we will never go to the well. During our Golden Jubliee we have assured that we would not got to the well. But, when atrocities were being committed on scheduled caste and scheduled tribe servicemen, we became so agitated that all Members including from BJP and all other parties went to the well. I wanted an assurance in the interest of service of Scheduled Castes and Scheduled Tribes from hon. Prime Minister, who gave it promptly, therefore, I am grateful to him. As far as 3-4 OM's issued by the Department of Personnel are concerned, hon. Prime Minister made good efforts for withdrawing one of these circulars. But how much time you would take in withdrawing rest circular. Three, six and eight months have passed, even cabinet decision was taken once, but orders are not being issued. I would only say that it is Prime Minister wish and will, and I will not blame him. He wants to help dalits. I would like hon. Prime Minister to take steps in this direction, then only I would believe that the Prime Minister and the Government have soft corner for SCs, STs and other minorities. Mr. Deputy Speaker, Sir, even the Prime Minister has said, but we do not know what happens in the Department. Not commenting unnecessarily, I would like to say only this much that I am interested in our people getting justice and employment. I urge hon. Prime Minister to assure as to when orders withdrawing OM's would be issued so that the injustice being done to Scheduled Castes and Scheduled Tribes employees comes to an end.

THE PRIME MINISTER (SHRI ATAL BIHARI VAJPAYEE): Mr. Deputy Speaker, Sir, the issue raised by hon. Shindeji is very important. There is no difference of opinion over this issue between the Government and the opposition. The Government desire that the condition of Scheduled Castes and Scheduled Tribes should improve. Justice should be done to SC/ST employees and justice means that we should try to rectify the system whereby injustice has been done to them or they have been neglected. The policies have been framed with this objective. But often, these policies are challenged in court of law. The House may remember that the Government twice brought Constitution (Amendment) Bill, which was passed with consensus since there was no difference of opinion about that. The third point raised by him is regarding jobs. The matter is under consideration of the Government. The problem is that the matter is in the court before the Constitution Bench. We expect a favourable decision from there very soon. Government is committed in this regard. We wanted to bring such a bill prior to the current budget session of the Parliament, however, we are making efforts once again and seek your support in this regard....(Interruptions)

SHRI RAJESH RANJAN alias PAPPU YADAV (Purnea): Mr. Deputy Speaker, Sir, I am drawing your attention continuously for the last 5 days towards the issue of Bihar. Bihar has become a serious issue for the country. Yesterday also 6 persons belonging to Dalit community were killed in district Sasaram. 5 days ago. 213 houses of most backward and dalit people were set on fire in Jangltola and a child was thrown into fire. There is no exaggeration of saying that Bihar Government is protecting the culprits. The situation in Bihar is so worse that since Panchayat elections have started and three level of Panchayati elections are still to take place. more than 200 people have already been killed. It is difficult to say that how many murders will take place but no village in Bihar has been left where incidents of firing is not taking place, where communal riots are not erupting and where frenzy and terrorised atmosphere is not being created. Not only the criminals also but the Government machinery, Government workers and Ministers and MLAs are also involved in it openly. Candidates are being murdered there. Election Commission restrained a Minister from visiting a constituency but he avoided it and reached there and was even involved in firing. Situation is so volatile there that no representatives of people is safe there and it is really difficult to express the actual situation prevailing there...(Interruptions)
