

>Title: Regarding death of two dalits in Saharanpur District, Uttar Pradesh.

THE DEPUTY PRIME MINISTER AND IN CHARGE OF THE MINISTRY OF HOME AFFAIRS AND MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI L.K. ADVANI): Sir, I have a different submission to make. Is it fair to deny the opportunity to those Members who have given notices for Question Hour, which are listed in the Question List? If anything has to be said, it should be said in 'Zero Hour' and not in Question Hour. That is my submission **â€** (Interruptions)
