Title: Demanded a thorough Parliamentary probe into the agreement signed by the Government of India and a US-based private company IUNET regarding the implementation of the Sankhya Vahini project of the Ministry of Communication.

SHRI PRIYA RANJAN DASMUNSI (RAIGANJ): Mr. Speaker, Sir, through you, I would like to bring to the notice of the Government and the entire House a very important matter. Though the matter has already been raised, yet it has not been answered.

Today, in the newspapers, we all read a news item. In the presence of the hon. Prime Minister, the BJP took their Members into confidence in regard to the *Sankhya Vahini* project. Of course, it is the right of their Party to do that. We have no questions about that. But I want to point out the manner in which the arrangement has been made to a private company through a Joint Venture Project violating all the established norms and practices of the Government in the past. A sum of Rs.94.26 crore has been budgeted for this project this year about which the Standing Committee on Communications has made a very strong recommendation. I quote:

"…The Committee strongly recommends that the matter should be looked into in-depth and fullest disclosure should be made as to why a particular technology has been selected without following the usual procedure and why DTS was kept out of the process of evaluation. The Committee strongly recommends a full review of the matter before the Joint Venture Agreement is fully entered into."

The question of the country's security as also the apprehension of espionage has been raised widely in the media. Almost all the parties in the country, cutting across party lines, have been raising this for the last two months. The envisaged project cost is Rs.1300 crore for which a provision has now been made. 49 per cent equity has been offered to the IU Net, 45 per cent to the DoT and 4 per cent to the individual institutions of India...(Interruptions)

MR. SPEAKER: Shri Dasmunsi, during the discussion of the Demands for Grants relating to the Ministry of Communications, many hon. Members raised this matter and the Minister also replied to that.

SHRI PRIYA RANJAN DASMUNSI (RAIGANJ): What I am trying to say is that during the discussion on the Demands for Grants, this issue was taken up but it was not addressed.

How can a joint venture deal be signed without inviting tenders? That is why it favours the agents of the United States. ...(*Interruptions*) Mr. Speaker, Sir, we demand that the Government should come out with full disclosure. We demand a discussion and a probe by a Parliamentary Committee. This is a matter of security of the country. We, from Congress Party, demand a Parliamentary probe and a full disclosure in the House. How can a Government enter into an agreement without identifying the equipment? ...(*Interruptions*)

MR. SPEAKER: Shri Dasmunsi, the Minister is going to reply now.

SHRI PRIYA RANJAN DASMUNSI (RAIGANJ): Mr. Speaker, Sir, I am concluding. I only submit that the Government should honour the recommendation of the Standing Committee. There should be a full Parliamentary probe and full disclosure of this Bill, which is causing concern for the security of the country and possible espionage. ...(Interruptions)

MR. SPEAKER: Shri Kurup, do you want to raise the same issue?

SHRI SURESH KURUP (KOTTAYAM): Yes, Sir. ... (Interruptions)

Now, he is keeping quiet. Probably he has been offered a ministerial berth! This is not a matter to be settled between Shri Khurana and the Prime Minister. The country has to know about the facts. Circumventing the established route of inviting global tenders, an MoU is signed between the Government of India and the IUNET, a U.S.-based company. They are not investing anything and mysteriously they own 49 per cent of the shares. ...(Interruptions) The Telecom Commission was informed two months after the MoU is signed. ...(Interruptions)

MR. SPEAKER: Shri Kurup, please understand. During the discussion on the Demands for Grants of the Ministry

also, the Minister has replied to the matter raised by some of the hon. Members.

SHRI PRIYA RANJAN DASMUNSI: This is a very serious question. ...(Interruptions)

MR. SPEAKER: How can you raise the matter again and again.

SHRI SURESH KURUP The Prime Minister himself has responded defending this commercial deal. The country wants to know as to what is the shady deal. ...(Interruptions)

MR. SPEAKER: Now, the Minister is replying. Please listen.

SHRI P.C. THOMAS (MUVATTUPUZHA): We would like to hear from the hon. Prime Minister. ...(Interruptions)

MR. SPEAKER: Please take your seat. This is not the proper way to raise the matter. You have raised the matter and the Minister has replied during the discussion on the Demands for Grants of the Ministry. What is this?

SHRI SURESH KURUP : The Prime Minister defended the deal in the BJP meeting. The House wants to know..… ...(Interruptions)

MR. SPEAKER: Other Members have also given notices in regard to a very important matter. Please understand. Please do not obstruct other Members.

SHRI PRIYA RANJAN DASMUNSI : Mr. Speaker, Sir, just as the Prime Minister took his party into confidence, let him take Parliament into confidence. ...(*Interruptions*)

MR. SPEAKER: If you behave like this, it will be very difficult for me to conduct the House. You have raised an important issue and the Government wants to reply

to that. But you are not allowing the Minister to reply. What is your intention? This is not correct. Please take your seats.

Sir, the other House is going to discuss this matter tomorrow under Calling Attention Motion. If the Opposition wants to discuss this matter further in this House, the Government has no hesitation because we have nothing to hide about this project. We are ready for a discussion. At the same time, let me inform the hon. Member, Shri Priya Ranjan Dasmunsi, that even though he is opposing this

project here and asking for a parliamentary probe, which is totally absurd and unnecessary, the Chief Minister of Maharashtra, who belongs to his party, has written that the Sankhya Vahini project should be implemented and the headquarter should go to Mumbai. This is the demand made by his own party's Chief Minister. So, there is nothing to hide and it is a clear project in the national interest. ...(Interruptions)
