How many people were killed, how many post mortems were conducted, how many were buried, it should be categorically stated in the House. The relatives of the people who have been killed should be immediately given compensation be it a Hindu or a Muslim. We want Minister of Parliamentary Affairs to announce Rs. Five lakh as compensation from the Prime Minister's Relief Fund. The people who have been looted should be given compensation. Our demand is, that action should be taken against the looters, even if they are policemen or belong to P.A.C....(Interruptions)

SHRI SHRIPRAKASH JAISWAL (Kanpur): Mr. Speaker, Sir an atmosphere for riot is being created in entire Uttar Pradesh. Bhartiya Janata Party is losing miserably in the elections to the local bodies....(Interruptions) Similar situation is being created in district Hathras also....(Interruptions) The Chief Minister of U.P. is visiting all the districts to guide the officers....(Interruptions)

SHRI UTTAMRAO DHIKALE (Nasik): Mr. Speaker, Sir, I wish to speak about our problem in Maharashtra....(Interruptions)

SHRI UTTAMRAO DHIKALE: Load shedding is not being done merely for two to three hours but it is being done for two to three days....(Interruptions) All the farmers of Maharashtra are quite worried as far as power is concerned. Dissatisfaction is pervading....(Interruptions) Coupled with it is the drought in certain areas owing to shortage of rains in Maharashtra....(Interruptions) All the dams are without water. There is problem of drinking water....(Interruptions) There is no water for the field. Thus two problems have cropped up before us. On one side there is water crisis coupled with shortage of power. What the farmers will do. 'Rasta Roko' protest is being staged at several places....(Interruptions). Maharashtra which should get 1700 Megawatt of power from the National Grid is only getting 1400 Megawatt. Uran Project of Maharashtra which has a capacity of generating 900 megawatt of power out of that 400 megawatt should be allotted to Maharashtra. This is my request to the Union Government....(Interruptions)

MR. SPEAKER: You may please conclude now.

SHRI UTTAMRAO DHIKALE: Therefore, I will request the Union Government that the farmers of Maharashtra be given electricity....(Interruptions) They are agitating and blocking the traffic as they are not getting power....(Interruptions)
