SHRI SUDIP BANDYOPADHYAY (CALCUTTA NORTH WEST): Sir, the Scheduled Castes, Scheduled Tribes, Minorities and women are being tortured, killed and murdered in the State of West Bengal. There is a constitutional breakdown there. After being defeated in the Lok Sabha Bye-Election and Calcutta Municipal Corporation elections, the Communist Party of India (Marxist) has taken the districts of Midnapur, Bankura and city to ransom...(Interruptions)

MR. SPEAKER: After him, I will call you, Shri Acharia.

MR. SPEAKER: Nothing should go on record except what Shri Sudip Bandyopadhyay is saying.

MR. SPEAKER: I have called Shri Sudip Bandyopadhyay. After him, I will call you.

SHRI SUDIP BANDYOPADHYAY: Sir, the parliamentary democratic system is at stake in the State of West Bengal. Hundreds of Scheduled Castes, Scheduled Tribes and Minorities have been killed during the last three months only. It is the appropriate time to demand imposition of article 356 in the State of West Bengal. In Keshpur, Pingla, Sabang, Garbeta, Goghat, Hoghly district and Bankura, in each and every part of the State, there is no democracy. Even the Chief Minister and the Police Minister are accusing Kumari Mamata Banerjee. The Police Minister is making statements on the floor of the House that Kumari Mamata Banerjee should be arrested. This is the state of affairs going on there....(Interruptions)

MR. SPEAKER: Now Shri Basu Deb Acharia.

SHRI SUDIP BANDYOPADHYAY: Sir, this is the state of affairs in West Bengal....(Interruptions)

MR. SPEAKER: Hon. Members, if you behave like this, it will be very difficult to run the House. I am telling you frankly. The entire nation is watching us. How we are behaving in the House, the entire country is watching. You are not bothered about anything. What is this? How can I accommodate all the Members at a time? Now nothing should go on record except what Shri Acharia says.
