Title: Alleged report published in a National daily against the Chief Minister of Punjab.

MR. SPEAKER: Shri Sukhbir Singh Badal may please speak now.

May I make a request? Shri Sukhbir Singh Badal, as you know, no submission which is an allegation in nature can be made against a person who is not present in the House. Please keep that in mind and make your submission.

SHRI SUKHBIR SINGH BADAL (FARIDKOT): Sir, first of all I would like to thank you for giving me this opportunity.

MR. SPEAKER: Yes, I would have given you this opportunity if you had not unnecessarily created a situation which was avoidable.

SHRI SUKHBIR SINGH BADAL: Sir, there has been a complete break down of Constitutional machinery in the State of Punjab. It seems that there are two rules in the State of Punjab. One to harass the political opponents and the Opposition and the other to protect the Government and the ruling party politicians.

And there is one law to protect the Government and the Government politicians. This is a scam which was not unearthed by us as a political party. This scam was unearthed by a leading national daily, the *Hindustan Times*. If you read that newspaper, if you see the style in which it was published, you will be surprised. It is not even published here.... (*Interruptions*)

MR. SPEAKER: You cannot show that. You cannot display that here.
