MR. SPEAKER: I have to look into it. I have admitted one Adjournment Motion. I cannot really admit every Adjournment Motion which is given. I have to see that. Shri Prabhunath Singh, we have discussed this matter. I shall allow you a discussion. But I have to see that. The trouble is that you do not even listen to the Speaker. I have to try to do my duty. Just because you have given notice of a motion, you want it immediately decided or discussed. I have to see that. Now, I have to consider what is the effect of the Supreme Court's order. I have to consider it. Therefore, allow me a little time to consider that. I have not got the Supreme Court's order also. Therefore, I have to see whether the discussion is permitted or not. Do not lose patience. Why are you losing patience?
