(Mr. Deputy-Speaker in the Chair)

MR. DEPUTY-SPEAKER: Now, item No. 20 - Matters under rule 377, may be treated as laid on the Table if the House agrees, and they would form part of the proceedings.

... (*Interruptions*)

SHRI PAWAN KUMAR BANSAL (CHANDIGARH): Sir, for Matters under rule 377, we wait for a week's time. If we just give a notice for 'Zero Hour', that is taken up. Here, we wait for the ballot because we want certain points to be raised. It is not just a matter of laying on the Table; there are certain matters concerning our constituencies which we want to raise. This is not a very good practice. I must say with all humility, this is not the right way of dealing with Matters under rule 377. Scrap Matters under rule 377; we would stop giving notices and start shouting during 'Zero Hour'. ... (Interruptions)

MR. DEPUTY-SPEAKER: The hon. Speaker has taken the decision. What can I do now?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE AND MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI BIJOY HANDIQUE): It is not that it is always laid; it is also read. Today, we are hard pressed for time. ... (*Interruptions*)

SHRI RAVI PRAKASH VERMA (KHERI): It would take only 15 minutes. We can extend the time of the House by 15 minutes. ... (*Interruptions*)

SHRI PAWAN KUMAR BANSAL: Sir, we can take it up at six o'clock. We would wait for that. We can take it up at the end of the day. Treat them like 'Zero Hour' matters. ... (*Interruptions*)
