Title : Need to set up a new railway zone in Kerala.

SHRI N.N. KRISHNADAS (PALGHAT): Sir, this is a very serious matter. It is regarding people of Kerala. There is a widespread apprehension and anxiety among the people throughout Kerala. Immediately after the announcement made by the hon. Railway Minister in this very House, we know that the Railway Ministry is going to bifurcate Palakkad Division and going to set up the new Salem Division. We are not against the interests of the people of Tamil Nadu; they are our friends and Tamil Nadu is our neighbouring State. ...(*Interruptions*) Our plea is that the biggest Palakkad Division might be continued as at present.

MR. SPEAKER: Please be brief; it is not the time for making speeches.

SHRI N.N. KRISHNADAS : There is a long-pending demand of Kerala. I request the Minister to create a separate Railway Zone, centrally in Kerala. If the Government is setting up a new Division, there should be a new Zone, centrally for Kerala.

MR. SPEAKER: Okay; it is no good repeating it.

SHRI N.N. KRISHNADAS : It is a very serious matter and an important one. We want an assurance from the Government. All the Members of Parliament from Kerala are supporting this. ...(*Interruptions*)

SHRI P.C. THOMAS (MUVATTUPUZHA): I want to say one thing.

MR. SPEAKER: No. Nothing can be said.
