Title: Regarding the proposal of Airports Authority of India to shift Bagdogra Airport.

SHRI PREM DAS RAI (SIKKIM): "Bagdogra is the only airport for Sikkim and North Bengal. It also serves as the most important airport for a large area including Bhutan, Lower Assam, Eastern Bihar and Eastern Nepal.

The Airport is the hub for tourists visiting Eastern Himalaya and Sikkim including now Mansarover. It has seen a considerable growth in air traffic, which crossed 1 million for the first time in 2014-15, growing at over 40% percent compared to last year.
