SHRIMATI MEENAKASHI LEKHI (NEW DELHI): Hon. Speaker, Madam, I want to bring to the notice of the House and the Government that there are about 400 ground handling companies appointed at the Airport, which employ close to three lakh people; and as per the new policy, its para 19 authorizes the airport operators to choose, and only through them, appointments can made...(*Interruptions*) Through those appointments, if the number of companies is restricted, then it would lead to a lot of unemployment amongst the people who are handling the ground handling services. ...(*Interruptions*) If the policy authorizes the airlines to do it, then it would be an unwholesome burden on the airlines to deal with the ground handling services. Better option is to allow the airlines to pick up their own ground handling company and, in return, get the handling done by those people. In that view, para 19 needs to be re-looked.
