Title: Demand of discussion on anti-farmers policy of importing wheat costing about Rs.1000 crore by the State Trading Corporation.

DR. Y.S. RAJA SEKARA REDDY: Sir, the State Trading Corporation has imported wheat costing about Rs. 1,000 crore. This policy is totally anti-farmers policy... (Interruptions)... The State Trading Corporation has imported wheat worth Rs. 1000 crore.

In the month of February 1998 all this has been done. Without proper tendering this has been done. This is totally an anti farmer policy. When the Food Ministry and the Agriculture Ministry have categorically stated that there is no need for importing wheat, the Commerce Ministry has gone ahead and imported the wheat.

Another very important thing is that whereas the procurement price which is being paid to a farmer is Rs.510, the imported price is Rs.850 per quintal. This is meaningless, absurd.

This is very very important. The anti farmer policy of the Government is also to be discussed. At least a hundred crore rupees kickback is involved in this entire thing.
