## **OBITUARY RÉFERENCE**

## [English]

MR. SPEAKER : Hon. Members, I have to inform the House of the sad demise of one of our former colleagues, Shri A.K.A. Abdul Samad.

Shri A.K.A. Abdul Samad was a Member of Seventh and Ninth Lok Sabhas representing Vellore Parliamentary Constituency of Tamil Nadu from 1980 to 1984 and 1989 to 1991.

Earlier, Shri Abdul Samad was a Member of Rajya Sabha from 1964 to 1976. He was also a Member of the Legislative Assembly, Tamil Nadu from 1984 to 1988.

An active parliamentarian, Shri Abdul Samad was a Member of various Parliamentary Committees in Lok Sabha and Rajya Sabha.

A businessman by profession, Shri Samad was a wellknown social worker. He was associated with various organisations in different capacities. He worked relentlessly for the welfare of the downtrodden and promotion of higher education for minority communities.

A widely travelled person, Shri Samad was a Member of Indian Parliamentary Delegation to Yogoslavia in 1971 and the Government of India's Haj Delegation in 1971 and 1989.

As a man of letters, he authored many books in Tamil. He was founder Editor of 'Mani Chudar' a Tamil Daily and 'Mani Vilakku' a Tamil Monthly.

Shri A.K.A. Abdul Samad passed away on 11 April, 1999 at Chennai, Tamil Nadu at the age of 73 years.

We deeply mourn the loss of this friend and I am sure the House will join me in conveying our condolences to the bereaved family.
