#### \*FIFTIETH REPORT

(SECOND LOK SABHA)

I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee, present on their behalf this their Fiftieth Report.

- 2. The Committee met on the 8th September, 1959 for-
  - Classification and Allocation of time for discussion of the Bills (vide Appendix) under Rule 294(1) (b) and 294(1) (c) of the Rules of Procedure respectively.
  - (2) Allocation of time for discussion of the motion for concurrence given notice of by Shri Diwan Chand Sharma in regard to Orphanages and Other Charitable Homes (Supervision and Control) Bill by Shri Kailash Bihari Lall (Member of Rajya Sabha) referred to Joint Committee by Rajya Sabha.

3. The Members concerned had been invited to present before the Committee their views on their Bills. Sarvashri Ram Krishan Gupta and Jhulan Sinha, who are also the members of the Committee, attended the sitting.

#### II. Classification and allocation of time to Bills

4. After considering all aspects of the Bills, the Committee placed all the 3 Bills in Category 'B' and allotted time for each of the Bills as shown in Appendix.

# III. Allocation of time to the Motion for concurrence

5. The Committee also allotted 2 hours for discussion of the Motion given notice of by Shri Diwan Chand Sharma for concurrence in regard to Orphanages and other Charitable Homes (Supervision and Control) Bill by Shri Kailash Bihari Lall (Member of Rajya Sabha) referred to Joint Committee by Rajya Sabha.
