**O** N behalf of the Committee on Private Members' Bills and Resolutions, I, having been authorised by the Committee, present this their Twenty-second Report.

2. The Committee met on the 5th March, 1955 to consider the Resolutions set down in the List of Business for Friday, the 11th March, 1955.

3. The Members whose resolutions had been included in the List of Business for the 11th March, 1955 were also invited to be present at the meeting. Two of them attended the meeting.

4. With respect to the first Resolution on the List of Business, relating to the setting up of a Corporation for Broadcasting, which remained part-discussed on the 25th February, 1955, the Committee noted that as against 1 hour and 15 minutes allotted for its discussion in their Twentieth Report the resolution had actually been discussed for one hour and seventeen minutes thus exceeding the allotted time by two minutes. As the resolution remains partdiscussed, the Committee recommend that an additional time not exceeding 15 minutes over and above the time taken up on the 25th February, 1955 may be allotted for its further discussion on the 11th March, 1955.

5. The Committee having considered all aspects with respect to the Resolutions in the List of Business for the 11th March, 1955, recommend the following time-table:—
