1, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee, present on their behalf, this their Thirty-eighth Report.

2. The Committee met on the 19th September, 1955 to consider allotment of time to the Resolutions set down in the List of Business for Friday, the 23rd September, 1955.

3. The Members whose Resolutions had been included in the List of Business for the 29th September, 1955 were also invited to be present at the sitting. One of them attended the sitting.

4. The Committee considered a representation received from Shri Bishwa Nath Roy and 32 other members for increasing the time allotted to the resolution regarding the appointment of a Commission to suggest measures for the development of Indian Shipping which had been moved by Shri Raghunath Singh on the 9th September, 1955. The Committee after considering all aspects of the resolution and taking into account the importance of the subject matter decided to extend the time of 3 hours already allotted to this resolution by 45 minutes.
