SIXTEENTH REPORT

I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Sixteenth Report.

2. The Committee met on the 10th April, 1978 for—

- I. Further consideration of classification and allocation of time to the Code of Civil Procedure (Amendment) Bill, 1978 (*Amendment of section 80*) by Shri Baldev Singh Jasrotia.
- II. Classification and allocation of time for discussion of Bills (*vide Appendix*) under clauses (b) and (c) of Rule 294(1) of the Rules of Procedure.
- III. Allocation of time under rule 294(1)(e) of the Rules of Procedure to the resolutions at item Nos. 3, 4 and 5 set down in the List of Business for Friday, the 14th April, 1978.

Further consideration of Classification and allocation of time to the Code of Civil Procedure (Amendment) Bill, 1978 (Amendment of section 80) by Shri Baldev Singh Jasrotia

3. Shri Baldev Singh Jasrotia, Member-in-charge of the Bill, was invited to attend the sitting. He did not attend.

4. After considering all aspects of the Bill, the Committee recommend that the Bill be placed in category 'B' and 2 hours be allocated for its discussion.

Classification and allocation of time to Bills

5. The Members concerned had been invited to present before the Committee their views on their Bills. None of them attended.

6. After considering all aspects of the Bills, the Committee recommend that all the Bills referred to in the Appendix be placed in category 'B'. The Committee recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.

7. The Members concerned had been invited to present their views on their resolutions before the Committee. None of them attended.
