SEVENTH REPORT

/Committee

- I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Chairman to present the Report on their behalf present this Seventh Report.
 - 2. The Committee met on the 21st November, 1977 for-
 - Classification and allocation of time for discussion of Bills (vide Appendix) under clauses (b) and (c) of Rule 294(1) of the Rules of Procedure.
 - Reconsideration of the classification of the Mental Health Bill, 1977 by Dr. Sushila Nayar.
 - III. Allocation of time under Rule 294(1)(e) of the Rules of Procedure to the resolutions at item Nos. 2, 3 and 4 set down in the List of Business for Thursday, the 24th November, 1977.

Classification and allocation of time to Bills

- 3. The Members concerned had been invited to present before the Committee their views on their Bills. Sarvashri C. K. Chandrappan, Samar Guha, P. K. Deo, P. Rajagopal Naidu and G. S. Reddi, M.Ps. attended.
- 4. After considering all aspects of the Bills, the Committee recommend that (i) the Constitution (Amendment) Bill, 1977 (Insertion of new article 326A) by Shri C. K. Chandrappan, (ii) the Income-tax (Amendment) Bill, 1977 (Amendment of section 10) by Shri Kanwar Lal Gupta and (lii) the Andaman and Nicobar Islands (Alteration of Name) Bill, 1977 by Shri Samar Guha be placed in category 'A' and all the remaining Bills be placed in category 'B'. The Committee recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.

Reconsideration of the Classification of a Bill

5. The Committee then reconsidered the request of Dr. Sushila Nayar to reconsider their earlier decision (vide First Report) and place her Bill, namely, the Mental Health Bill in category 'A'. Dr. Sushila Nayar, who had been invited, did not attend the aitting.

On reconsideration, the Committee recommend that the Bill might be placed in category 'A'.

Allotment of time to Resolutions

- 6. The Members concerned had been invited to present their views on their resolutions before the Committee. Sarvashri A. K. Saha and Saugata Roy attended.
 - 7. The Committee recommend the allocation of time as follows:—
 - (1) Resolution regarding parity between the production and prices of agricultural and industrial products.
