NINTH REPORT

- I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Ninth Report.
 - 2. The Committee met on the 5th December, 1977 for-
 - I. Classification and allocation of time for discussion of Bills (vide Appendix) under clauses (b) and (c) of Rule 294(1) of the Rules of Procedure.
 - II. Allocation of time under Rule 294(1)(e) of the Rules of Procedure to the resolutions at item Nos. 2 and 3 set down in the List of Business for Friday, the 9th December, 1977.

Classification and allocation of time to Bills

- 3. The Members concerned had been invited to present before the Committee their views on their Bills. Shri D. D. Desai attended.
- 4. After considering all aspects of the Bills, the Committee recommend that the prohibition on Indication of Caste Bill, 1977 by Shri D. D. Desai be placed in category 'A' and all the remaining Bills be placed in category 'B'. The Committee recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.
