#### TWENTY THIRD REPORT

#### (Presented on 13-8-1986)

I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Twenty-third Report.

2. The Committee met on 12 August, 1986 for classification and allocation of time for discussion of Bills (vide Appendix) under clauses (b) and (c) of Rule 294(1) of the Rules of Procedure.

Classification and allocation of time to Bills

3. The Committee considered classification and allocation of time to thirteen Bills specified in Appendix.

4. After considering all aspects of the Bills, the Committee recommend that the following Bills be placed in category 'A':---

- (1) The Forest (Conservation) Amendment Bill, 1986 (Amendment of section 2) by Shri S. G. Gholap.
- (2) The Constitution (Amendment) Bill, 1986 (Insertion of new article 38A etc.) by Shri Balasaheb Vikhe Patil,
- (3) The Constitution (Amendment) Bill, 1986 (Amendment of article 163) by Shri P. Kolandaivelu.
- (4) The Medical Termination of Pregnancy (Amendment) Bill, 1986 (Amendment of sections 3 and 4) by Shri Sharad Dighe.

The Committee further recommend that all the remaining nine Bills be placed in category 'B'. The Committee recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.

#### Recommendations

5. The Committee recommend that the classification and allocation of time to Bills by the Committee, as shown in the Appendix, be agreed to by the House.
