THIRTIETH REPORT

- I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Thirtieth Report.
 - 2. The Committee met on 24 November 1981 for-
 - I. Classification and allocation of time for discussion of Bills (vide Appendix) under clauses (b) and (c) of Rule 294(1) of the Rules of Procedure.
 - II. Reconsideration of the classification of the following Bills:-
 - (1) The Constitution (Scheduled Castes) Orders (Amendment) Bill, 1980 by Shri G. S. Reddi.
 - (2) The Mercy Killing Bill, 1980 by Shri Mool Chand Daga.

Classification and allocation of time to Bills

- -3. The Committee considered classification and allocation of time to 13 Bills specified in Appendix.
- 4. After considering all aspects of the Bills, the Committee recommend that the following Bills be placed in category 'A':—
 - 1. The Code of Criminal Procedure (Amendment) Bill, 1981 (Amendment of section 125) by Shrimati Pramila Dandavate.
 - 2. The Consumers' Grievances Settlement Bill, 1981 by Shri R. K. Mhalgi.
 - 3. The Indian Telegraph (Amendment) Bill, 1981 (Amendment of section 5) by Shri Atal Behari Vajpayee.
 - 4. The Indian Post Office (Amendment) Bill, 1981 (Amendment of section 26) by Shri Atal Behari Vajpayee.
 - 5. The Widows' Pension Bill, 1981 by Shri Virdhi Chander Jain.
 - The Construction Workers' Protection and Welfare Bill, 1981 by Shri George Fernandes.

5. The Committee further recommend that all the remaining 7 Bills be placed in category 'B'. The Committee recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.

Reconsideration of the Classification of Bills

- 6. The Committee then considered the requests of Sarvashri G. S. Reddi and Mool Chand Daga to reconsider their earlier decisions (vide Ninth and First Reports respectively) regarding the classification of the following Bills:—
 - The Constitution (Scheduled Castes) Orders (Amendment) Bill, 1980 by Shri G. S. Reddi.
 - 2. The Mercy Killing Bill, 1980 by Shri Mool Chand Daga.
- 7. On reconsideration, the Committee recommend that both the Bills may be placed in category 'A'.

Recommendations

- 8. The Committee recommend that-
 - (i) the classification and allocation of time to Bills by the Committee, as shown in the Appendix, be agreed to by the House; and
 - (ii) the reclassification of the Bills, as shown in paragraph 7 above, be agreed to by the House.
