#### FIFTH REPORT

## (Presented on 22-8-1985)

I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Fifth Report.

2. The Committee met on 19 August, 1985 for classification and allocation of time for discussion of Bills (*vide* Appendix) under clauses (b) and (c) of rule 294(1) of the Rules of Procedure.

### Classification and allocation of time to Bills

3. The Committee considered classification and allocation of time to nine Bills specified in Appendix.

4. After considering all aspects of the Bills, the Committee recommend that (i) the Constitution (Amendment) Bill, 1985 (Insertion of new Part XA) by Shri Ananda Pathak and (ii) the Payment of Unemployment Allowance Bill, 1985 by Prof. P. J. Kurien, be placed in category 'A' and all the remaining seven Bills be placed in category 'B'. The Committee recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.

#### **Recommendations**

5. The Committee recommend that the classification and allocation df time to Bills by the Committee, as shown in the Appendix, be agreed to by the House.
