#### EIGHTH REPORT

#### (Presented on 4-12-1985)

- I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Eighth Report.
- 2. The Committee met on 2 December, 1985 for classification and allocation of time for discussion of Bills (vide Appendix) under clauses (b) and (c) of rule 294(1) of the Rules of Procedure.

#### Classification and allocation of time to Bills

- 3. The Committee considered classification and allocation of time to nine Bills specified in Appendix.
- 4. After considering all aspects of the Bills, the Committee recommend that (i) the Essential Commodities (Procurement and Distribution) Bill, 1985 by Shri R. P. Das, (ii) the Special Educational Facilities (For Children of Economically Backward Parents) Bill, 1985 by Shri R. P. Das and (iii) the Constitution (Amendment) Bill, 1985 (Amendment of article 311) by Shri C. Janga Reddy, be placed in category 'A' and all the remaining six Bills be placed in category 'B'. The Committee recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.

#### Reommendations

5. The Committee recommend that the classification and allocation of time to Bills by the Committee, as shown in the Appendix, be agreed to by the House.
