#### THIRTY-THIRD REPORT

- I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Thirty-third Report.
  - 2. The Committee met on the 20th November, 1973 for-
