 - *(1) The Constitution (Amendment) Bill, 1967 (Amendment of article 368) by H.H. Maharaja Sriraj Meghrajji Dhrangadhra.
 - *(2) The Constitution (Amendment) Bill, 1967 (Amendment of articles 4, 80 etc.) by Shri Shiva-Chandra Jha.

CLASSIFICATION AND ALLOCATION OF TIME TO BILLS

EXAMINATION OF THE CONSTITUTION (AMENDMENT) BILLS

5. The Members who had given notices of the Bills and representative of the Ministry concerned with the Bills had been invited to be present at the sitting. H.H. Maharaja Pratap Keshari Deo attended the sitting. The representative of the Ministry of Law was present.

FINDINGS OF THE COMMITTEE

- 6. The Committee considered the Bills and arrived at the following findings as a result of their examination of the Bills:-
 - (1) The Constitution (Amendment) Bill, 1967 (Amendment of article 368) by H.H. Maharaja Sriraj Meghrajji Dhrangadhra.

The Bill sought to amend article 368 of the Constitution so that in the case of a Bill seeking to amend any of the provisions relating to Fundamental Rights contained in Part III thereof, the President may, after the Bill has been passed by the Houses of Parliament and before giving his assent, ascertain the views of the electorate through a referendum.

After considering all aspects of the Bill, the Committee recommended that the Member might be permitted to move for leave to introduce the Bill.

(2) The Constitution (Amendment) Bill, 1967 (Amendment of articles 4, 80 etc.) by Shri Shiva Chandra Jha.

The Bill sought to provide that the Council of States shall consist of, in addition to 12 nominated Members, 4 representatives from each of the States and Union territories

iestead of the number of representatives allocated in the Fourth Schedule to the Constitution.

After considering all aspects of the Bill, the Committee recommended that the Member might be permitted to move for leave to introduce the Bill.

Recommendations

- 7. The Committee recommend -
 - (i) that the classification and allocation of time to Bills by the Committee as shown in Appendix be agreed to by the House; and
 - (11) H.H. Maharaja Sriraj Meghrajji Dhrangadhra and Shri Shiva Chandra Jha be permitted to move for leave to introduce their Constitution (Amendment) Bills.
