Abstract of the Proceedings of the Council of the Governor General of India, assembled for the purpose of making Laws and Regulations under the provisions of the Act of Parliament, 24 & 25 Vic., cap. 67.

The Council met at Government House, on Tuesday, the 21st December, 1875.

INDIAN TELEGRAPH BILL.

The Hon'ble Mr. Hobhouse presented the Report of the Select Committee on the Bill to amend the law relating to Telegraphs in India.

STAMPS AND COURT FEES BILL.

The Hon'ble Mr. Inclis moved for leave to introduce a Bill to consolidate and amend the law relating to Stamps and Court Fees. He said that the main object of this Bill was to consolidate into one compact and clearly expressed enactment the law relating to Stamps and Court Fees, which was now scattered over nine or ten Acts, a large number of notifications of the

Government of India, and several decisions of the High Courts—a state of things which was necessarily productive of great inconvenience to the public. At the same time advantage had been taken to settle certain points of doubtful law, and clear up certain difficulties which had been felt in the construction of Act XVIII of 1869. He would not take up the time of the Council by making any further remarks on the present occasion, but would reserve what he had to say in explanation of the provisions of the Bill till he introduced it, if the Council would give him permission to do so.

The Motion was put and agreed to.

REFORMATORY SCHOOLS BILL.

The Hon'ble Sir A. J. Arbuthnot moved that the Hon'ble Raja Narendra Krishna be added to the Select Committee on the Bill to provide Reformatory and Industrial Schools. He said it seemed desirable that a Native member of the Council should be on the Committee on that Bill.

The Motion was put and agreed to.

The Council then adjourned to Tuesday, the 4th January, 1876.
