## COMMITTEE ON PRIVATE MEMBERS' BILLS AND RESOLUTIONS

#### THIRTEENTH REPORT

(SECOND LOK SABHA)

- I, the Chairman of the Committee on Private Members' Bills and Resolutions having been authorised by the Committee, present on their behalf, this their Thirteenth Report.
- 2. The Committee met on the 11th February, 1958 to consider allotment of time to the Resolutions set down in the List of Business for Friday, the 14th February, 1958.
- 3. The Members whose Resolutions had been included in the List of Business for the 14th February, 1958 and the representatives of the Ministries concerned had been invited to present their views on these Resolutions before the Committee. Sarvashri M. L. Dwivedi and Satis Chandra Samanta and the representatives of the Ministries of Education and Scientific Research and Food and Agriculture attended the sitting.
- 4. The Committee after hearing the representatives of the Ministries concerned with the Resolutions and considering all aspects with respect to the resolutions in the List of Business for the 14th February, 1958, recommend the following time-table:-
  - (1) Resolution regarding Appointment of Out of the total time of 2 hours allotted to a Committee to review the working of banks for the purpose of nationalisation.
    - this resolution I minute was taken up on the 13th December. 1957. The balar ce of I hour and 59 minutes would be available on the 14th February, 1958.
  - (2) Resolution regarding Nationalisation 1 hour. of Panna Diamond Mines.
  - (3) Resolution regarding Commission to 21 hours. inquire into indiscipline among students.
  - (4) Resolution regarding Co-operative 2½ hours. Farming.
