No. 639 SHRI RAM TAHAL CHOUDHARY:

Will the Minister of Housing and Urban Affairs be pleased to state:

(a) whether the Central Public Works Department is not achieving its objectives due to corrupt practices;

(b) if so, the reaction of the Government thereto;

(c) the number of officers found guilty following the investigations / reviews conducted by the Government in the functioning of Central Public Works Department (CPWD) during the last three years along with the names of such officers; and

(d) the steps taken by the Government to check corruption in CPWD?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE

(a) & (b) : The objectives of the Central Public Works Department (CPWD) of creating and maintaining infrastructure assets of the Government and other bodies are being achieved by carrying out works in a competitive and transparent manner with sound engineering

practices. Appropriate mechanisms exist in the department to detect and deal with corrupt practices.

(c): The list of officers against whom major, minor penalty proceedings have been initiated based on investigations and Criminal / CBI prosecution cases during the years 2015, 2016 and 2017 are given in the statement at Annexure-A, Annexure-B and Annexure-C.

(d) : The steps taken by the CPWD to check corruption include carrying out regular / surprise inspections, leveraging technology for transparency e.g. e-payment, e-tendering, e-procurement, e-sewa kendras and e-project management, examination of pending audit paras, examination of Annual Property Returns, systemic improvement in Manual Provisions and Procedures, conducting training / awareness programmes for CPWD officers as part of preventive vigilance measures etc.
