Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Skill development centres have been set up by the Government under Pradhan Mantri Kaushal Vikas Yojana in various parts of the country, if so, the details thereof since the inception of the scheme, State-wise including Chhattisgarh, Bihar, Uttar Pradesh and Rajasthan;
- (b) the locations of skill development centres under PMKVY set up in each State;
- (c) the number of trainees enrolled in each of the skill development centres as on 31 January, 2018; and
- (d) whether the Government has suspended further new allocation under the scheme in some States and if so, the details thereof and the reasons therefor?

DEVELOPMENT CENTRES'**

(a) to (c) Pradhan Mantri Kaushal Vikas Yojana (PMKVY) does not mandate establishment of Skill development centres but enables large number of prospective youth for taking Short Term Training (STT) and Recognition of Prior Learning (RPL) through accredited and affiliated training centers (TCs) throughout the country.

Under the PMKVY 2015-16, about 13,000 Training Centres were involved for imparting skill training. However, under PMKVY 2016-20, the registration of TC is being done under single window IT application known as SMART. Under PMKVY 2016-20, as on 29.01.2018, about 7,549 TCs are operational. The State/UT-wise Chhattisgarh, Bihar, Uttar Pradesh and Rajasthan number of operational training centres and candidates enrolled under them are given at **Annexure-I**.

(d) Under Centrally Sponsored Centrally Managed (CSCM) component of PMKVY 2016-20, during the course of implementation, it was found that target allocation has crossed the geographical ceilings in case of few States. Hence, it has been decided not to allocate further target under CSCM component of PMKVY 2016-20, till March 2018.
