THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SOMPAL): (a) and (b) The accounts of National Dairy Development Board (NDDB) are being audited as per provisions made under section 28 of the National Dairy Development Board Act, 1987 (37 of 1987) by auditors duly qualified to act as auditors of Companies under the Companies Act and the appointment of auditors and remuneration payable to them is subject to approval of the Central Government.

(c) On a request from the Comptroller and Auditor General of India (CAG), the Central Government by an order dated 6.6.97 conveyed to the CAG approval of the President to audit the accounts of NDDB under section 14(2) of the CAG's (DPC) Act, 1971 for the years 1988-89 to 1995-96. However, pending examination of certain legal issues raised by the NDDB subsequent to the issuance of the above order, Government requested the CAG not to take up the audit until after these issues are examined and settled. The matter has not been finally decided. In the meantime the NDDB has obtained stay from the High Court of Delhi against the implementation of the order dated 6.6.97.
