## Manufacturing of Silicon Chips

- 3171. SHRI SUSHIL CHANDRA VARMA: Will the PRIME MINISTER be pleased to state:
- (a) whether it is fact that silicon chips are being imported in the country;
  - (b) if so, the reasons therefor:
- (c) whether any research has been conducted to manufacture silicon chips in India;

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE MINISTRY OF FINANCE (BANKING, REVENUE AND INSURANCE) (SHRI KADAMBUR M.R. JANARTHANAN): (a) Yes, Sir.

- (b) As per Government policy, Silicon Chips i.e. Integrated Circuits (ICs) on a chip of silicon are freely importable. Silicon Chips cover a wide variety of highly complex products such as microprocessor (Pentium processors, Sparc processors), memories (Dynamic Random Access Memories, Static Random Access Memories), Digital Signal Processor etc. These are produced only by a few well established global companies such a Intel, NEC, Motorola, Hitachi, Texas Instruments, Toshiba, Samsung etc.
- (c) and (d) Silicon chips based on bipolar as well as metal oxide semiconductor technology are manufactured in the country to a limited extent. M/s SCL, a public sector undertaking of the Department of Electronics, manufactures Silicon chips for telecom and time keeping applications a well as application specific silicon chips for strategic as well as civilian requirements.

(a) to (f) The Survey on Consumer Expenditure is conducted by National Sample Survey Organisation at regular intervals. These surveys classify people into various categories according to their Monthly Per Capita Consumption expenditure. The data on income is not collected. These classifications are widely accepted and used in the Governments. The percentage of people in each expenditure class as per the survey conducted in 1993-94 is given in the statement enclosed.
