Telephone Exchanges in J & K

THE MINISTER OF STATE IN THE MINISTRY OF COM-MUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) The number of Telephone Exchanges working as on 31.5.1998 in J&K Circle are 252.

- (b) Telephone Exchanges are opened on the basis of demand. Hence, it is difficult to make comparison with other States on this basis. However, telephone density, i.e. number of Telephone/100 persons is better in J&K Circle than in many other. Circles.
- (c) The development of Telecom Services in Telecom Circles of the Department including J&K is being planned to achieve the objective of providing Telephone on demand by the end of 9th Five Year Plan viz. 2002.

THE MINISTER OF HUMAN RESOURCES DEVELOP-MENT AND MINISTER OF SCIENCE AND TECHNOLOGY (DR. MURLI MANOHAR JOSHI): (a) to (c) An inquiry was conducted by this Ministry into the complaints for financial irregularities in respect of the purchase of computer hardware etc. and a report has been submitted to the Central Vigilance Commission for advice.

(d) Computers are purchased by National Informatics Centre (NIC) for Government organisations mainly through NIC's own budget for connecting to NICNET. However, as and when any Government Department/Organisation approaches NIC for assistance in the procurement of hardware and software, procurement is made according to NIC's procedures, if the budget is transferred to NIC. NIC also gives technical support in the procurement of computer hardware according to their own prescribed procedures.

Hydro Po:ver Projects in Himachai Pradesh

OF **POWER** (SHRI THE MINISTER P.R. KUMARAMANGALAM): (a) and (b) Three hydroelectric Projects namely Kol Dam (800 MW), Parbati Stage II (800 MW) and Chamera Stage II (300 MW) have been cleared by the Central Electricity Authority (CEA) from techno economic angle The investment sanction will be accorded for Kol Dam Hydroelectric Project and Parbati Stage II only after implementing agencies are identified in consultation with State Government of Himachal Pradesh. Investment approval for Chamera Stage II would be considered only after on an assessment is made by CEA regarding the completion costs based on different modes of execution.

The schemes, namely Budhil (70 MW), Malana (86 MW) and Renuka Dam (40 MW) have been submitted by HP Government to CEA. The techno economic clearance will be accorded after scrutiny by the CEA.

Six schemes namely Allain Duhangan (192 MW), Dhamwari Sunda (70 MW), Hibra (231 MW), Karcham Wangtoo (1020 MW), uhl (100 MW) and Parbati Stage III (510 MW) have since been returned by CEA to State Government for resubmission. These projects will be considered by CEA for techno economic clearance as and when various issues raised are satisfactorily resolved.

These requests are under examination in the Ministry of Textiles.

Import and Export of Power

(1) * Bhutan

India is importing power from Chukha Hydro Electric Project in Bhutan for some years. Government of Bhutan also imports power from west Bengal and Assam State Electricity Boards.

(2) Nepal

Power exchange between india and Nepal commenced in October, 1971. The quantum of exchange of power which was initially upto 5 MW has been raised to 50 MW. The exchange of power takes place at 17 places along with Indo-Nepal border through the existing transmission network.

(3) Bangladesh

The Governments of India and Bangladesh have agreed to prepare a joint feasibility report for inter-connection of power systems between Bangladesh and India. The Asian Development Bank has agreed to finance a feasibility study for exchange of power between India and Bangladesh under its Regional Technical Assistance Programme, A Tripartite Meeting has been held at ADB, Manila on 29th and 30th May. 1997 regarding the Project. The project envisages export of surplus power from Eastern region of India to Western Bangladesh. The project also envisages export of surplus power from Eastern Bangladesh to the North Eastern Region of India,

- There is no proposal to suspend the export or (c) import of power.
