MURLI MANOHAR JOSHI): (a) to (c) A proposal regarding setting up of Mizoram University is under active consideration of the Govt. in pursuance of the Peace Accord between the Mizo National Front and the Govt. of India. At present, colleges in Mizoram are affiliated to the North-Eastern Hill University, Shillong. It is proposed to locate the new University at Aizawl.

Bus Service between Calcutta and Dinaka
